The Borough of Wandsworth Community Trust is asking for your help to fund projects that will directly benefit communities and drive improvements within the borough.

In the consultation carried out in April last year, you told us that you would be most keen to fund measures which improve the lives of young people who live in Wandsworth. This is why the Trustees have chosen Children and Young People as our first priority area for the Trust. Within this priority area, Trustees have drawn upon council data and an assessment of the borough's needs carried out by the Public Health team to identify potential themes for support:

- Enable Children to thrive in their education and support Young People into employment. We know that the pandemic has caused disruption to children's education and made it harder to access traditional paths to employment like work experience and apprenticeships. Your donation could fund groups to provide measures such as mentoring and extra support programmes which help children and young people gain confidence and bounce back into education and/or the workplace.
- **Supporting Children and Young People's mental health**. Again, we know the burden of the pandemic has weighed on young people, and research has shown that the rate of children with mental health needs has increased by 25% during the pandemic. Your donation could help provide much needed counselling to a young person or activities for young carers. We would also be keen to fund measures which support and strengthen parents and carers' mental health, recognising the strain the pandemic has put on them.
- Supporting Healthy Choices and Activities. Being active is key to a child's wellbeing. Your donations could allow the Trust to support a range of groups which promote getting active, from football and boxing to cycling and dance!
