

Wandsworth Council's Topline Performance Indicator Results for 2009/10

What are the Topline measures?

Wandsworth Council uses a variety of performance indicators to monitor how well its services are performing and to measure their efficiency and effectiveness. The Council has led the way in developing a comprehensive system of performance measurement which sets challenging targets for services and measures performance regularly against these targets.

The Council's Overview and Scrutiny Committees focus on a set of key indicators of performance called 'toplines'. The topline indicators include all the National Indicators introduced by Government in 2008, as well as a range of other local measures agreed annually that relate to the delivery of the council's priorities. They measure performance across a wide range of Council activity including social services, education, housing, and leisure services, libraries and street cleansing.

The topline indicators also include all those indicators for which we and our partners on the [Wandsworth Local Strategic Partnership](#) have agreed targets with the Government through the [Local Area Agreement](#). There are also a number of indicators which relate to activity carried out by the Council with its partners, particularly the health service and the police.

The 2009/10 topline performance indicator results are set out in the detailed tables below.

How they are monitored

These indicators are monitored quarterly by the Council's Directors and Cabinet Members against the agreed targets for that year. Reports are also submitted to the Chairmen of the relevant Overview and Scrutiny Committees in the Progress Reports three times per year in the June (end of year performance), November (quarter 2 performance) and February (quarter 3 performance) cycles. This report pulls together each of these reports into one place. You can view the Progress Reports and all other committee reports through the Council's website: www.wandsworth.gov.uk/moderngov.

The end of year performance against targets is also reported annually in the Council's [Corporate Business Plan](#) (CBP). The CBP 2010 also sets out the council's priorities and targets for the following three year period.

The following key is provided to help you interpret the performance reports.

Actual 2008/09

This column includes the latest annual results for indicators covering the following periods (unless otherwise stated):

- Calendar year 2008
- Financial year 2008/09
- Academic year 2007/08

Latest data available at the end of 2009/10

For the vast majority of indicators the data reported in this column will relate to the 2009/10 financial year. However, for several indicators, and often those where the data is released centrally by the Government or its agencies, data are published many months in arrears. The latest data that is available for each indicator for the 2009/10 period is therefore presented in this column. Where necessary, a comment (“comment on latest available data”) has been provided in the adjacent column to indicate what period the data covers. If there is no comment then the indicator result relates directly to 2009/10.

Target 2009/10

This column includes the agreed target for end of year performance. Targets are not set for those indicators that are survey-based or where limited or no data has been available to aid target-setting.

Target achieved?

This column provides a simple red / green traffic-light assessment to indicate whether or not the Council’s agreed target was met.

Key to direction of travel column

An assessment is made only where there are two periods that are comparable both in terms of definitions and the period that each data point covers. In the tables below this usually means 2009/10 compared with 2008/09.

Please note that the direction of travel arrow takes account of whether a high or low performance values is considered good on any particular indicator:

- ▲ – performance improved
- ▼ – performance deteriorated

— – no change

n/c –data displayed does not allow reliable comparisons to be made.

NI – National Indicator (indicators set by the Government that all local authorities are required to report their performance against annually)
