The site is not uneven and does not present any known risks. Surfaces around the site are a combination of tarmac, concrete paving and various internal floor surfaces all regularly used by users of the lido and its facilities.

Specific items of P.P.E. are not considered necessary although it is suggested that the Inspector provides him/herself with wellington boots or similar footwear if wet weather conditions prevail at, or immediately before, the time of the visit.

2. Is there any likelihood of exposure to pets or other animals which may present a risk to the safety of the Inspector?

Little or no likelihood within the Lido enclosure. As the Lido is located on open common land it is possible that pet dogs, under the control of their owners/walkers will be present in the area immediately around the Lido enclosure. This presence should not present any risk to the Inspector although it is suggested that the Inspector should be made aware of this potential before the site visit.

3. Is the site remote and/or can it be seen from other occupied buildings/property/public land/roadside?

The site is not immediately overlooked by any other buildings, but is not considered to be "remote" in that it is within 40 metres of a well used public car park and 120 metres from Tooting Bec Road. It should be noted that the Lido is a popular recreational facility which attracts many visitors during the summer season (May to September inclusive)

4. Does the site have a good mobile phone signal or is there easy access to a public telephone should the emergency services be required?

Mobile 'phone signal in the area is considered to be good and reliable.
