

### **Kersfield Estate** Previous Proposal - 2016

Here are the proposals we showed you in 2016. We have been working on designs following feedback from residents, the planning department and surveys carried out on the estate.



Existing ground floor homes given new accesses directly onto courtyard spaces

> New 3 - 4 storey flatted blocks facing Lytton Grove, accessed from the street

Potential new 2-3 storey houses facing Lytton Grove

### **Key Feedback On Proposal**

- Back gardens should change/we would prefer communal gardens instead.
- More seating areas/relaxing/pleasure garden for community/picnic or bbq area.
- The footpath proposal was liked.
- Existing residents wanted more benefits for them.
- Residents like the open nature of the southern part of the estate and wanted this to be kept.

### **Our Response**


- We have included the under used gardens in Rosbury and Sprewell into public open space.
- We have included footpaths around the site improving routes across the site.
- We have increased the height of the southern blocks but reduced the footprint of it to free up space and keep the open nature of the estate.
- We have removed one of the blocks to the south,
- The buildings to the north should be smaller/ or shouldn't be built.
- The new communal areas should feel safe and discourage anti social behaviour.

### Kersfield Estate Scheme Proposal - 2018

- Proposed buildings which range from 2 4 storeys.
- Buildings added to the ends of existing buildings.
- New blocks proposed near to Rosbury and **Essington facing onto Lytton Grove**
- 39 new homes proposed. 35% affordable.

New 4 storey flatted blocks added to the south end of **Essington & Sprewell accessed** from the new path and existing estate


### **Kersfield Estate** Block Design

We are currently progressing designs, on this page you can see the size and height of the new buildings which we will be developing towards a planning application.




The proposed buildings step up in size and height responding to the buildings and slope of Lytton Grove.


