## Annex 2 - Conditions consistent with the operating Schedule

### Crime & Disorder

#### CD19 Bottle Bans

1. No glass bottles containing beverages of any kind, whether open or sealed, shall be given to customers on the premises whether at the bar or by staff service away from the bar.
2. No customers carrying open or sealed bottles shall be admitted to the premises at any time that the premises are open to the public.
3. Customers who are seated in (insert area) for the consumption of food may be sold bottles containing wine for consumption with a table meal.

#### CD4 Latest Admission

4. That there shall be no admission or re-admission of patrons to the premises after 24.00 hours (midnight) unless the patrons are ticket holders or the patrons names are included on a guest list.

#### CD8 Promoters

5. The licensee shall be responsible for ensuring that any promoter using the premises shall use only staff, including door supervisors, employed by the licensee unless the prior approval of the Licensing Authority has been obtained.

#### CD9 Responsibility of Licensee

6. No soliciting for custom, including the distribution of leaflets, shall take place from the premises, immediately outside the Premises or in the vicinity of the premises.
7. Where a licence has been granted to a company, the licensee must appoint a duty manager or duty managers who shall be in charge of and upon the premises at all material times. In such cases, the licensee shall notify the Licensing authority of the names of those persons appointed duty managers. In addition, a copy of the written authorization must be kept on the premises and be readily available for inspection by any police officer or authorized officer.

#### CD10 Security, admission

8. Admission shall be refused to any person found with or suspected of carrying or under the influence of drugs or carrying an offensive weapon.

#### CD11 Security, incidents

9. All staff must report immediately to their manager instances where patrons appear to be in distress.

### Public Safety (including Fire Safety)

#### General

#### PS2 Accommodation Limit

10. The maximum number of persons to be accommodated on the premises at any one time shall not exceed 100.

#### PS3 Alterations

11. No alterations (including temporary alterations) shall be made to the premises without the consent of the Licensing Authority. This condition shall not require notice to be given in respect of routine maintenance works.
12. Where works necessitate the premises being closed for a period of time, the premises shall not reopen for the purpose of the licence without the consent of the Licensing Authority.

#### PS4 Animals, etc

13. A minimum of 14 days' notice in writing shall be given to the Licensing Authority of any intention to use any live animal, bird or fish in a performance on the premises.

#### PS5 Attendants

14. During the whole time members of the public are present on the premises there shall be a sufficient number of competent adult staff. These staff shall have been specially instructed by the licensee or person nominated by him as to their duties in the event of an emergency. The instruction given to staff shall include training on the avoidance of panic and the safe evacuation of the premises.
15. Such staff shall not be engaged in any duties, which:
  - (i) would hinder the prompt discharge of their duties in the event of any emergency

(ii) entail their absence from that floor, tier, or auditorium where they are on duty.

16. Such staff shall not be engaged in any sales duties, which involve the use of trays or similar equipment when the normal lighting is dimmed or extinguished.

#### PS7 Change of Use

17. The use of the premises for which a licence has been granted shall not be changed without the consent of the Licensing Authority

#### PS8 Charge of Licensed Premises/Duty Manager

18. The duty manager shall be familiar with all licence conditions.

19. The duty manager shall not engage in any duties, which will prevent general supervision of the premises. The duty manager shall whenever necessary be assisted by suitable adults.

20. Before admitting the public the duty manager shall carry out all necessary safety checks as identified by the health and safety risk assessment for the premises/activity.

21. The duty manager shall maintain good order at the premises

22. A competent person shall be in charge of the electrical or other installation whilst the public are on the premises.

#### PS9 Cleanliness of Premises

23. All parts of the premises shall be kept in a clean condition.

#### PS10 Compressed Gases and Liquids

24. Cylinders for the storage of compressed air, oxygen, or other gases or liquids under pressure shall not be used except with the consent of the Licensing Authority. At least 14 days' notice in writing shall be given to the Licensing Authority of any proposal to use such apparatus.

#### PS11 Construction of Premises

25. The construction of the premises shall be such as to minimize the risk of fire involving the structure. This can be achieved by adopting methods of construction, which comply with the minimum requirements of the Building Regulations.

#### PS12 Dancing

26. Dancing shall be restricted to the areas approved for that purpose.

27. Smoking shall not be allowed in the approved dance area at any time it is being used for dancing.

#### PS13 Dangerous Performances

28. Performances involving danger or risk to the public shall not be given.

#### PS14 Disabled Persons

29. The premises shall be provided with access, facilities and satisfactory means of escape for disabled persons.

#### PS15 Frontages

30. The premises shall abut upon and have such frontage to a street, way or open space having direct access to a street as the Licensing Authority shall approve as sufficient to ensure the rapid dispersal of persons from the premises in the event of fire and to afford satisfactory access and working space for fire appliances.

#### PS17 Maintenance and Testing

31. The approved arrangements at the premises, including means of escape Testing provisions, fire warning and fire fighting equipment, the electrical installation and mechanical equipment, shall at all material times be maintained in good condition and full working order.

#### PS18 Overcrowding

32. Overcrowding shall not be permitted in any part of the premises.

33. The licensee shall maintain a register indicating the numbers of staff who are on duty at all material times in the area where entertainment is provided. This register shall be produced immediately on the request of a police officer or an authorised officer.

34. The licensee shall ensure that the accommodation limit specified on the licence is not exceeded and shall at all material

times be aware of the number of patrons on the premises. This information shall immediately be provided on request to a police officer or authorised officers when they have reasonable cause for suspecting the accommodation limit may be exceeded.

#### PS19 Pop Concerts

35. Entertainment commonly known as a pop concert shall not be given without the Licensing Authority's consent. At least one month's notice shall be given in the event of any intention to use the premises for a pop concert. The application shall give the names of the groups or artists booked to appear (if known) together with an indication of the age and profile of the audience the entertainment is expected to attract.

#### PS20 Prohibition on use (Hypnotism, Mesmerism)

36. No person shall give at the premises any exhibition, demonstration or performance of hypnotism, mesmerism or any similar act or process which produces or is intended to produce in any other person any form of induced sleep or trance in which susceptibility of the mind of that person to suggestion or direction is increased or intended to be increased.

NOTE: This rule does not apply to exhibitions given under the provisions of Section 2(1a) and 5 of the Hypnotism Act 1952.

#### Emergency Arrangements & Fire Safety

##### PS23 Curtains, Hangings, Upholstery, Decorations etc

37. Applications for consent to use curtains and hangings shall be made in writing and shall be accompanied by full details including a certificate in respect of fire-retardancy issued by a recognised laboratory e.g. one accredited by UKAS.

38. Only hangings, curtains, upholstery and temporary decorations complying with the relevant British (or where appropriate European) Standard shall be used. Where necessary these shall be periodically tested for flame resistance and retreated as necessary to the satisfaction of the Licensing Authority.

39. In the case of a temporary decorations a statement must be provided advising the period it is desired to retain the decorations.

40. Curtains and hangings shall be arranged so as not to obstruct fire safety signs, fire extinguishers or other fire fighting equipment.

41. Curtains across doors shall be hung in two halves on a free running rail to enable them to be parted easily. Such curtains shall have a clearance of at least 25mm between the bottom of the curtain and the floor.

42. Applications for consent for all upholstery (whether provided new or second-hand) shall be made in writing and shall be accompanied by full details, including a certificate in respect of fire-retardancy issued by a recognised laboratory e.g. one accredited by UKAS showing that the upholstery composite of each item has been tested.

##### PS24 Doors & Fastenings

43. Any exit door or gate shall open in the direction of escape and shall be hung so as not to obstruct, when open, any gangway, passage staircase or landing. Such door or gate shall be free from fastening other than panic bolts or such fastening as may be approved by the Licensing Authority. Panic bolts shall be of the type and pattern and installed in accordance with the appropriate British Standard.

##### PS25 Escape Routes Separation & Enclosures

44. The means of escape from the premises shall be enclosed and protected against the action of fire and portions of the premises considered by the Licensing Authority to constitute or contain a particular fire risk shall be separated from the remainder of the premises to the Licensing Authority's satisfaction.

##### PS26 Exit Notices

45. All exit notices required by the Licensing Authority shall be provided with adequate means of illumination from each system of lighting or shall be of the self-luminous type.

##### PS27 Exits

46. All means of egress approved by the licensing Authority shall be clearly indicated.

##### PS28 Fire Alarms

47. A fire alarm system shall be installed throughout the premises to the satisfaction of the Licensing Authority.

48. Any fire alarm system shall be maintained in satisfactory working order. The system shall be maintained and serviced in accordance with the current British Standard and tested regularly in accordance with conditions imposed by the Licensing

Authority. All checks, tests and defects shall be recorded in the logbook.

#### PS29 Fire Appliance

49. The approved fire appliances shall be kept in the approved positions and be maintained in satisfactory working order so as to be available for instant use.

50. Portable fire appliances shall be inspected at least once a year in accordance with the relevant British Standard and the date of the inspection clearly marked on the appliance or on a stout tab securely attached to it. Extinguishers shall be inspected and recharged in compliance with the manufacturer's instructions.

51. Any hydraulic hose reels shall be inspected once a year to ensure that they are in working order and the date of the inspection clearly marked on the appliance or recorded in a log book.

52. Any drenchers or sprinklers shall be inspected once a year to ensure that they are in working order and the date of the inspection clearly marked on the appliance or recorded in a log book.

#### PS30 Fire appliances & Equipment

53. Fire appliances and equipment for the protection of the premises shall be provided to the Licensing Authority's satisfaction.

#### PS31 Fire Duties

54. All parts of the premises shall be inspected by an appropriately trained member of staff at the end of every event/performance in order to ensure no fire exists and to identify any possible fire risk.

#### PS32 Fire Duties, Emergency Procedures

55. Particulars of the emergency procedures shall be posted in areas approved by the Licensing Authority. These notices shall be framed and glazed or otherwise suitably protected against loss or defacement.

56. Particulars of the duties of staff with specific responsibilities in the case of fire and other emergency shall be reviewed from time to time as changes in staff or other circumstances shall require.

#### PS33 Fire Duties, Fire Drill

57. A fire drill and/or emergency procedure instruction shall be held at least once a month (or more frequently if required by the Licensing Authority) under the direction of the duty manager.

#### PS34 Fire Duties' Logbook

58. The licensee shall ensure that a logbook is kept to record the holding of the fire drills and the carrying out of checks. The licensee or duty manager shall initial the logbook weekly and the book shall be open to inspection at any reasonable time by authorised officers.

#### PS35 Fire Safety, General Arrangements

59. The general arrangements of the premises shall be such as the Licensing Authority considers satisfactory to facilitate the safe and orderly evacuation of all persons therein accommodated in the event of fire

#### PS36 Fire Safety, Separation

60. The premises shall be separated, to the satisfaction of the Licensing Authority, from any other building or from any other portion of the building in which the premises are situated or from any adjoining fire risk.

#### PS37 Means of Escape

61. Exits shall be provided and so arranged as to afford ready means of escape from all parts of the premises.

62. The means of escape provided for the premises shall be maintained unobstructed, free of trip hazards be immediately available and clearly identified in accordance with the approved arrangements.

63. In restaurants and other premises where chairs and tables are provided clear gangways shall be provided in accordance with the approved arrangements.

64. No changes shall be made to the approved layout of the premises without the consent of the Licensing Authority.

65. All exit doors shall be available at all material times without the use of a key, code, card or similar means. The Licensing Authority must approve any fastenings or electrically controlled locks.

66. The means of escape must always be sufficient for the total number of persons present. Where there are an unusually large number of performers the Licensing Authority must be consulted.

67. Any approved removable security fastenings shall be removed from the doors prior to opening the premises to the public. All such fastenings shall be kept in an approved position.

68. All fire doors shall be maintained effectively self closing and not held open other than by an approved device.

69. Fire resisting doors to ducts, service shafts and cupboards shall be kept locked shut.

70. The edges of the treads of steps and stairways shall be maintained so as to be conspicuous.

#### PS38 Medical and First Aid Provision

71. The licensee shall keep a record to confirm the attendance of the paramedic or trained first aiders and must log any assistance given. This record must be made available to authorized officers on request.

72. All those responsible for first aid shall have special instructions on drug related problems and how to recognize and tackle, in particular, dehydration, heat stroke, anxiety and paranoia. The training shall also be given to all persons expected to staff the toilet areas.

#### PS40 Medical and First Aid Provision under 1000 patrons

73. A minimum of 2 persons trained in first aid must be in attendance at all times whilst the premises are open. Re-training of first aiders must take place every three years.

#### PS41 Outbreaks of Fire

74. The Fire Brigade shall be called at once to any outbreak or suspected outbreak of fire, however slight, and details thereof recorded in a logbook. Suitable notices shall be prominently displayed indicating how the Brigade can be summoned. The Licensing Authority shall be informed, as soon as possible, of any instance of fire.

#### PS42 Refuse Storage

75. A sufficient number of suitable receptacles for refuse storage shall be provided. These receptacles shall be maintained in a clean condition.

#### PS43 Staff Training

76. Staff with specific responsibilities in the event of fires or other emergency, together with deputies, shall receive training and written instruction appropriate to their role. The duty manager shall, once he is satisfied as to the competence of each member of staff, enter this in a logbook that shall be available for inspection by Police or authorised officers.

77. All staff shall initially be trained in the action to be taken in the event of an emergency and in basic fire prevention, including the rules concerning smoking and, thereafter, at least once every 6 months.

78. All full time staff shall receive instruction and training in the use of fire appliances provided on the premises

#### PS44 Staircases & Corridors

79. Any staircase, lobby, corridor or passage, where forming part of the means of escape from the premises, shall be of a uniform width not less than the width of the exit, or the aggregate width of the exits, from which it leads, and shall be so formed and arranged that nothing shall impede the free flow or prejudice the safety of persons using it.

#### PS45 Storage of highly flammable substances including pyrotechnics, maroons, blank ammunition, petrol, flammable gases and liquids

80. Highly flammable substances may only be brought on to the premises with the consent of the Licensing Authority.

81. Quantities must be limited to the practicable minimum necessary for the requirements of the presentation.

82. The Licensing Authority must approve the storage arrangements. No more than 0.6 litres of flammable liquid nor 2.3kg gross weight of pyrotechnics will normally be permitted on the premises unless kept in a store licensed by the appropriate authority.

83. Only the minimum amount of highly flammable material must be withdrawn from the store as is required for the particular performance.

84. Smoking and naked flame shall be prohibited in areas where highly flammable substances are stored and notices should be displayed both in rooms and on containers to this effect.

85. Storage areas and containers shall be indicated by the explosive/inflammable symbol on the door or lid and kept locked with the key in the possession of a responsible person.



#### PS46 Water Supply

86. The duty manager shall notify the Fire Authority immediately if the water supply to any hydrant, hose reel, sprinkler, drencher or other fire extinguishing installation is cut off or restricted.

87. Should the restriction occur during a performance in a theatre, or in the evening in other licensed premises, the premises may remain open for the remainder of the performance / evening but may not reopen without the approval of the Licensing Authority or until such time as the water supply is fully restored.

#### Building Services

##### Sanitary

#### PS47 Cloakroom & Sanitary Accommodation

88. Cloakroom and sanitary accommodation for each sex shall be provided, and shall have regard to the type of entertainment to be given at the premises.

#### PS49 Drinking Water

89. Free drinking water shall be made available. Drinking water taps shall be clearly marked as such and at least one point for cold drinking water e.g. a drinking water fountain, shall be provided in all sanitary accommodation.

#### PS50 Staff Facilities

90. Such dressing-room and staff-room accommodation for performers, musicians and staff shall be provided for each sex as the Licensing Authority may consider necessary, having regard to the use proposed to be made of the premises and the maximum number of persons to be employed.

#### PS51 Toilet Facilities

91. Free toilet facilities in proper working order shall be available as agreed by the Licensing Authority.

#### Lighting

##### PS52 Automatic Change-over contactor

92. Any automatic change-over contactor provided to transfer the escape lighting from the normal lighting supply to the battery supply shall be so designed as to operate immediately and efficiently to the Licensing Authority's satisfaction.

##### PS53 Construction and arrangements of Lighting Fittings

93. The construction arrangements and installation of light fittings shall be such as to reduce to a minimum the risk of interference, of fire and of injury to persons and comply with the appropriate British Standard

##### PS54 Electric Supply of Battery Circuits

94. The mains supply to the escape lighting control unit shall be obtained from a sub-main independently controlled at the main distribution centre for the premises.

##### PS55 Escape Lighting

95. The escape lighting installation, including its total load, shall not be altered without the consent of the Licensing Authority.

96. Any escape lighting battery shall be fully charged before the admission of the public.

97. Should the normal lighting and the escape lighting system have a 1 hour capacity the public shall leave the premises within 30 minutes unless within that time the normal lighting has been restored and the batteries are being re-charged. If the escape lighting system has a three-hour capacity the public shall leave the premises within 1 hour unless within that time normal lighting has been restored and the batteries are being re-charged. If the patrons have left the premises they shall not be readmitted until normal lighting has been fully restored and the battery or batteries fully recharged.

##### PS56 Escape Lighting Batteries

98. Unless otherwise permitted by the Licensing Authority, any battery supplying the escape lighting shall be capable of maintaining the full escape lighting load continuously for a period of not less than 3 hours.

##### PS57 Lighting Equipment

99. Lighting equipment used in the auditorium and on the stages and platforms shall be of stout construction, encased in rigid, non-combustible material and designed to withstand the temperatures caused by the illuminant without excessive temperature rise on the outer casing and to resist mechanical damage.

##### PS58 Lighting of Intake & Control Room

100. Where required by the Licensing Authority, escape lighting shall be provided within electric intakes and main switch and control rooms.

#### PS59 Lighting Requirements

101. All parts of the premises shall be provided with adequate means of illumination and, except where otherwise permitted by the Licensing Authority, those portions to which the public have access and all routes of escape for performers or staff shall be provided with adequate means of illumination from two independent sources.

#### PS60 Management Lighting

102. In the absence of adequate daylight in any area used by the public the management lighting in such areas shall be fully in operation whilst the public are on the premises.

103. If essential to the entertainment and agreed by the Licensing Authority, lighting in the entertainment area (except for fire safety signs) may be reduced or extinguished provided:-

- (i) The lighting is controlled from a position with a clear view of the audience
- (ii) An operator stands by such controls whilst the lighting is reduced or extinguished who shall restore the management lighting in the event of any emergency.

104. Fire safety signs shall be fully illuminated at all material times.

105. There shall be adequate illumination to enable persons on the premises to see their way out.

#### PS61 Segregation of the two systems of lighting

106. Where two lighting systems are provided each shall be so installed that a fault or accident arising on one system shall not jeopardise the other.

#### Heating/Ventilation

##### PS62 Air Conditioning

107. Any provision for air warming or conditioning shall be so arranged as to minimise to risk of contamination of the air supply by smoke or fumes.

##### PS63 Apparatus in Ducts

108. Electric motors and other apparatus shall not be installed in any air duct or in the air stream of any mechanical ventilation system except in so far as they form part of the ventilation system.

##### PS64 Boiler Chambers & Fuel Storage Chambers

109. Any boiler and any fuel storage chamber shall be constructed and arranged

- (i) to minimise the risk of fire and the spread of fire and smoke
- (ii) to limit the effect of any explosion
- (iii) in the case of oil fuel, to prevent the spread of any leakage of oil and to safeguard from fire any oil storage.

##### PS65 Cleansing of Flues, Ventilation Ducting and Shafts

110. The flue of any boiler or heating appliance shall be professionally cleaned at intervals not less than the minimum recommended by the appliance manufacturer.

111. Ventilation ducting and shafts generally shall be maintained in a clean condition.

112. Ventilation air filters shall be cleaned or changed for new filters periodically as may be necessary to maintain a satisfactory flow of air supply.

113. All interior surfaces of extract ventilation ducting serving kitchens and serveries shall be thoroughly cleaned at least annually.

##### PS66 Direction of Air

114. The ventilation of premises intended to be used for stage performances shall be such that the direction of air movement during such performances shall be from the auditorium towards the stage.

##### PS67 Heating & Ventilation

115. Provision shall be made to the satisfaction of the Licensing Authority for warming all parts of the premises regularly occupied by the public, the performers or the staff.

##### PS68 Limitation of Leakage

116. Where an oil-fired installation is designed to operate unattended, provision shall be made to limit the quantity of oil

which might flow into the boiler or generator chamber under gravity (or syphonic action) or by pumped delivery as a result of damage to the piping or apparatus.

#### PS69 Minimum Flash-point

117. Unless the Licensing Authority shall decide otherwise in any particular case apparatus burning oil having a closed flash-point below 66 degree C shall not be installed.

#### PS70 Oil Fired Heating Installations

118. Oil-fired heating and diesel generator installations shall be constructed and installed to prevent danger from fire or explosion.

#### PS71 Permanent Ventilation Rooms,

119. Enclosures, to be ventilated Ventilation shall be provided to enclosures, as the Licensing Authority may consider necessary.

#### PS72 Re-circulation, Refrigeration

120. Any elaboration of the basic ventilation systems, including re-circulation and refrigeration, shall be subject to such conditions as the Licensing Authority may require.

#### PS73 Self-contained Local Heating Equipment

121. Apparatus in which the heat is generated locally shall be installed only in approved positions.

#### PS74 Standard of Ventilation

122. Adequate ventilation shall be provided at all parts of the premises; and shall be such as

- (i) to exclude as far as practicable the entry and distribution of fire and smoke,
- (ii) to maintain hygienic conditions, and
- (iii) to facilitate the removal of any smoke or fumes direct to the open air.

#### PS75 Ventilation

123. The premises shall be effectively ventilated at all material times. In theatres and similar auditoria where the ventilation is designed to maintain a positive air pressure balance in the auditorium the ventilation system shall be operated so as to maintain the pressure balance at all material times.

#### PS76 Warming of Premises

124. Any means of warming the premises shall be installed in a permanent manner and carried out in accordance with such conditions as the Licensing Authority may require.

#### Electrical/Gas Installation

##### PS77 Apparatus to be enclosed

125. Except where specified by the Licensing Authority, main switches, meters and other electrical apparatus in connection with the intake from each independent source of supply, any apparatus used for generating, converting, transforming or rectifying electricity, and where required by the Licensing Authority, electrical motors, other electrical plant or machinery and any storage battery shall be installed in separate ventilated enclosures.

##### PS78 Compliance with I.E.E. Regulations

126. The Regulations of the Institution of Electrical Engineers shall be complied with except in so far as departure therefrom is required by any other condition on the licence.

##### PS79 Distribution Mains for Exhibitions

127. Permanent distribution mains with adequate means of connection, isolation and protection shall be provided in premises at which exhibitions etc. are frequently held so as to minimise the use of temporary wiring.

##### PS80 Gas Appliances Protection of Surroundings

128. Gas appliances shall be so arranged that a dangerous rise in temperature will not be caused in any combustible portions of the structure or decoration.

##### PS81 Gas Consuming Devices

129. Gas consuming devices shall be installed to the Licensing Authority's satisfaction so as to minimise the risk of leakage and/or explosion.

##### PS82 Gas Meters & Mains Controls

130. A main valve with readily operable handle and accessible only to authorised persons shall be provided.

#### PS83 Gas Piping

131. All piping of the consumers gas installation shall be of rigid hard metal and shall be securely fixed away from electrical wiring (except as required by the Regulations of the Institution of Electrical Engineers) and apparatus, and shall, where required by the Licensing Authority, be efficiently protected against corrosion.

#### PS84 Gas, Position of Appliances

132. Gas-fired cooking and heating appliances for space heating, shall be installed only in rooms or enclosures specially approved for the purpose by the Licensing Authority and ventilated direct to the open air.

#### PS85 High Voltage Apparatus

133. Apparatus for bulk supply of electricity at pressures exceeding low voltage shall be provided only with the Licensing Authority's consent and subject to such conditions as the Licensing Authority considers necessary.

#### PS86 Labelling of Switchgear

134. All switchgear and distribution board shall be clearly marked to indicate the circuits controlled.

#### PS87 Limitation of Voltage

135. Installations requiring voltages higher than low voltage shall not be provided except with the consent of the Licensing Authority and in accordance with the conditions of such consent.

#### PS88 Positions of Control Apparatus Within Reach of the Public

136. Switches, fuse boards and other control apparatus shall be so installed so as to minimise the possibility of interference by the public.

#### PS89 Precautions for Differing Voltages

137. In premises where the lighting fittings are connected to two or more electrical systems at sensibly different voltages, arrangements shall be made to ensure that lamps will be inserted only in lampholders supplied at the appropriate voltage.

#### PS90 Protection of Final Sub-Circuits

138. Overload protection (e.g. fuses or circuit breakers) to final sub-circuits shall be rated so as to afford protection to the apparatus permanently connected thereto.

#### PS91 Remote Control of Motors

139. Where an electrical motor is started manually from a remote position, an approved device shall be provided adjacent to the starting switch to indicate correct functioning of the motor.

#### PS92 Resistors, Reactors, Capacitors

140. All electrical equipment shall be adequately ventilated to prevent excessive rise of temperature under normal working conditions.

#### PS93 Systems of Wiring

141. Systems of wiring employed for permanent electrical installations shall be those in which all cables and conductors are enclosed throughout in protective covering of materials of adequate strength to resist mechanical damage. Such installations shall comply with the Regulations of the Institution of Electrical Engineers.

#### PS94 Temporary Electrical Installations

142. Temporary electrical installations shall not be provided without 14 days prior notification being given to the Licensing Authority.

143. Temporary electrical installations shall be inspected and certified by a competent person before they are put into use. A copy of the certificate shall be sent to the Licensing Authority.

144. Such temporary electrical installations shall only be acceptable for a period of up to 3 months. This period may be extended subject to a satisfactory electrical test and inspection report being submitted to the Licensing Authority at the end of each 3-month period.

#### PS95 Transformer Chambers & Switch Rooms

145. Any transformer chamber, switch room or enclosure for apparatus for main electricity supply or main gas meters shall be constructed and arranged

- (i) To minimise the risk of fire and the spread of fire and smoke
- (ii) To limit the effect of any explosion.

## Plant

### PS96 Access to Plant

146. Adequate means of access shall be provided to all machines and plant which require regular servicing or maintenance.

### PS97 Apparatus Working Under Pressure

147. Every boiler or other apparatus working under pressure shall be provided with safety devices and indicators to the Licensing Authority's satisfaction.

### PS98 Generator, Operating Instructions

148. Detailed instructions as to the operation of the installation shall be permanently exhibited in a suitable position or kept where they will be readily available to those responsible for the operation of the plant.

### PS99 Generator, Precautions Against Over-Filling

149. Provision shall be made to the satisfaction of the Licensing authority to prevent leakage of oil due to over-filling.

### PS100 Guarding of Machinery

150. Such precautions as the Licensing Authority may consider necessary shall be adopted to prevent accident from moving parts of machinery.

### PS101 Lifts & Conveyors

151. Any lifts, hoists, escalators or conveyors shall be installed so as to minimise risks from fire and accident.

### PS102 Smoke Outlets

152. Smoke outlets shall be provided from any basement boiler or transformer chamber and any room containing oil-immersed switch gear or similar apparatus and from basement car parks.

### PS103 Switchgear

153. Ample space shall be provided for the convenient operations and proper maintenance of all switchgear.

### PS104 Wiring in Lift and Ventilation Shafts

154. Lift shafts and ventilation ducts shall not be used as cable ways.

## Certificates

### PS105 Certificates

155. The certificates listed below shall be submitted to the Licensing Authority as specified:-

156. **Batteries** A certificate shall be submitted at least once every six months covering all escape lighting batteries (including any self-contained units) and associated control equipment.

157. **Electrical Installation** A certificate shall be submitted at least once a year covering the entire electrical installation (including the escape lighting installation). In large or complex premises the electrical installation shall be visually inspected once a year and at least 20% of the installation tested in accordance with a programme agreed with the Licensing Authority such that the whole installation is tested every five years. The certificate shall be signed by a Corporate Member of the Institution of Electrical Engineers or a member of the Electrical Contractors Association or by a contractor currently enrolled with the National Inspection Licensing Authority for Electrical Installation Contracting or, with the approval of the Licensing Authority, another competent person.

158. **Boilers and Calorifiers** A certificate of thorough examination and test by a boiler insurance company shall be submitted before any new boiler or calorifier is put into service. A certificate of thorough examination and test by a boiler insurance company shall be submitted thereafter at periods not exceeding:

- (i) For any steam boiler - one year
- (ii) For any electrode boiler working on a closed water system - three years
- (iii) For any calorifier incorporating a steam receiver - two years

159. **Ceilings** A certificate shall be submitted at least once every three years (or at shorter intervals if required by the Licensing Authority) covering ceilings and ornamental plasterwork in those parts of the premises to which the public are admitted.

160. **Fire Alarms** A certificate from a fire alarm company or with the approval of the Licensing Authority another person deemed competent shall be submitted at least once a year to the effect that the fire alarm installation satisfies the requirements of the current British Standard.

161. Fire Appliances Certificates shall be submitted at least once a year covering all portable fire appliances together with any hydraulic hose reels, drenchers or sprinklers.

#### Public Nuisance

##### PN1 Conduct of Premises

162. No poster, advertisement, photograph, sketch, synopsis or programme shall be displayed, sold or supplied anywhere by or on behalf of the licensee which is unsuitable for general exhibition. If the licensee is notified by the Licensing Authority in writing that it objects under this rule to a poster, advertisement, photograph, sketch, synopsis or programme, it shall not be displayed, sold or supplied.

163. The licensee shall ensure that no noise shall emanate from the premises nor vibration be transmitted through the structure of the premises, which gives rise to a nuisance.

164. Clear legible notices are to be displayed at all exits from the premises requesting patrons to respect the needs of local residents and to leave the premises and area quietly.

##### PN3 Hours of Closing, British Summer Time

165. On the morning that Greenwich Mean Time changes to British Summer Time one hour will be added to the terminal hour of licences having a terminal hour of later than 2.00am.

##### PN6 Litter

166. That all refuse to be placed in the containers outside the premises and in quiet and considerate manner and not be put out between the hours of 11.00pm and 8.00am.

167. That the Licensee arranges for suitable and effective clearance of all litter immediately upon closing.

##### PN10 Noise, Sound Limiting Device, Changes

168. That the sound limiting device installed at the premises be maintained at the levels previously approved by the Licensing Authority and that no changes be made to the set levels without its consent.

##### PN12 Noise, Sound Limiting Device, Password

169. That the key/password for the sound limiting device installed at the premises be kept by a third party nominated by the licensee and approved by the Licensing Authority and that no changes be made to the set levels without the consent of the Licensing Authority.

##### PN15 Windows and Doors

170. That all windows remain closed at all times and that all doors remain closed except during access and egress whenever the premises are used for entertainment.

#### Embedded Conditions Licensing Act 1964

##### PN19 Permitted Hours, Club Premises

171. Alcohol shall not be sold or supplied except during permitted hours as shown on pages one and two.

##### PN17 In addition

172. The permitted hours shall end at midnight on any day on which music and dancing is not provided after midnight.

173. On any day that music and dancing end between midnight and two o'clock in the morning, the permitted hours shall end when the music and dancing end.

174. In relation to a weekend morning on which summer time begins, the permitted hours shall extend to three o'clock in the morning, subject to 1 and 2 above.

175. Except on Sundays immediately before bank holidays, the permitted hours on Sundays shall extend until thirty minutes past midnight in the morning following except that -

- (a) The permitted hours shall end at midnight on any Sunday on which music and dancing is not provided after midnight;
- (b) Where music and dancing end between midnight on any Sunday and thirty minutes past midnight, the permitted hours on that Sunday shall end when the music and dancing end or, as the case may be, when gaming ends.

176. On Sunday immediately before a bank holiday, the permitted hours shall extend until 2.00am in the morning following except that -

- (a) The permitted hours shall end at midnight on any Sunday on which music and dancing is not provided after midnight;

(b) Where music and dancing end between midnight on any Sunday and 2.00am the permitted hours on that Sunday shall end when the music and dancing end or, as the case may be, when the gaming ends.

177. The sale of alcohol must be ancillary to the use of the premises for music and dancing and substantial refreshment.  
Protection of children from harm

#### CH1 Entertainment for Children

178. Entertainment specially presented for children shall not be given for children without the Licensing Authority's consent. At least 14 day's notice shall be given to the Licensing Authority of any intention to provide such entertainment in premises not normally used for children's entertainment.

#### CH2 Entertainment for Children

179. During the whole time that performances are specially presented for children a member of staff shall be stationed in the vicinity of each exit from any level occupied by children provided that on each level the minimum number of staff on duty shall be:

? Lowest level - 1 member of staff per 100 children or part thereof

? All other levels - 1 member of staff per 50 children or part thereof

#### CH5 Entertainment's Unsuitable for Some Audiences

180. When any television entertainment or part of such entertainment is described by the broadcasting authority in advance of the day on which it is to be broadcast as unsuitable for viewing by any particular group of persons, a notice to that effect, indicating the group of persons concerned, shall be displayed in a conspicuous position to the satisfaction of the Licensing Authority at each entrance to the premises.

#### CH6 Entertainment's Unsuitable for Some Audiences

181. Unless the consent of the Licensing Authority has been obtained no such entertainment shall be given on the premises during the time any child under or appearing to be under the age of 16 is therein unless the child is accompanied by an adult person bona-fide in charge of the child.

#### CH7 Prohibition on use (sexual Nature)

182. Any entertainment performance, service, or exhibition involving nudity or sexual stimulation which would come within the definition of a sex establishment in Schedule 3 to the Local Government (Miscellaneous Provisions) Act 1982 as amended by the Greater London Licensing Authority (General Powers) Act 1986, (whether or not locally adopted), shall not be provided.  
NOTE: This condition does not apply to any entertainment that is an integral part of a licensed performance of a play.
