

PUBLIC NOTICE:

ROAD TRAFFIC REGULATION ACT 1984

THE A3 GLA ROAD (WEST HILL, LONDON BOROUGH OF WANDSWORTH) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2025

1. Transport for London hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to allow water meter works to take place at A3 West Hill.
3. The effect of the Order will be to prohibit any vehicle from entering, exiting or proceeding on the West Hill off slip road connecting the westbound carriageway of the A3 West Hill with Tibbets Corner Roundabout.

The Order will be effective from 10:00 AM on 20th February 2025 until 6:00 PM on 23rd February 2025 or when those works have been completed, whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibition is in force alternative routes will be indicated by traffic signs via West Hill Southwest bound, Kingston Road, Roehampton Vale, Kingston Vale, Roehampton Vale, Kingston Road, Tibbets Corner to normal route of travel.

THE A3 GLA ROAD (WEST HILL, LONDON BOROUGH OF WANDSWORTH) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2025

Made

Coming into force

20th February 2025

Transport for London in exercise of the powers conferred by section 14(1) of the Road Traffic Regulation Act 1984^a, and of all other enabling powers, hereby makes the following Order: -

1. This Order may be cited as The A3 GLA Road (West Hill, London Borough of Wandsworth) (Temporary Prohibition of Traffic) Order 2025 and shall come into force on the 20th February 2025.
2. This Order is made because Transport for London is satisfied that traffic in the London Borough of Wandsworth should be prohibited from making certain movements on sections of A3 West Hill because works are being executed.
3. From 10:00 AM on 20th February 2025 until 6:00 PM on 23rd February 2025 or when those works have been completed, whichever is the sooner, subject to the provisions of article 4 below, no person shall cause or permit any vehicle to enter, exit, proceed or stop on the West Hill off slip road connecting the westbound carriageway of the A3 West Hill with Tibbets Corner Roundabout.
4. (1) The provisions of article 3 above shall apply only during such times and to such extent as may from time to time be indicated by traffic signs.

(2) The provisions specified in article 3 above shall not apply in respect of:
 - (i) any vehicle being used for the purposes of those works;
 - (ii) any vehicle on any occasion when it is being used for fire brigade, ambulance or police purposes if the observance of those provisions would hinder the use of the vehicle;
 - (iii) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.

5. At such times as the prohibition is in force an alternative route will be indicated by traffic signs.
