## **Heaver Estate – Elmbourne Road Traffic Calming, SW17**

Following on from the one-month trial of parking suspensions to reduce potential traffic conflict, the council would like to share with you the outcome.

As part of the investigation, traffic surveys, parking stress surveys, conflict surveys, and site observations were carried out to help assess the effectiveness of the trial. The council also reviewed a total of 139 responses from the online consultation and email feedback of the trial.

Following detailed discussions with ward councillors and the Cabinet Member for Transport, the agreed approach is to suspend parking fronting the Common between Tooting Bec Road and Hillbury Road and 4 spaces between Bushnell Road and Bedford Hill. The suspension will be in operation between 7am and 7pm, Monday to Friday from 2nd September 2024 and statutory consultation on a permanent solution will commence from 12th September 2024.

### The statutory consultation proposals are as shown on the plan overleaf and below:

- Replace 39 parking bays located on the Common Side between Tooting Bec Road and Hillbury Road with a single yellow line restriction, operational between 7am and 7pm Monday to Friday;
- Replace 4 parking bays located between Bushnell Road and Bedford Hill with a single yellow line restriction, operational between 7am-7pm Monday to Friday
- Raised zebra crossing on Elmbourne Road at the junction with Louisville Road
- In addition to this the "No Motor Vehicles Except for Access" from 9pm to 2am will be removed from the Heaver Estate as it is no longer required and some residents report it prevents taxi pick up/drop off

The council will be holding two drop-in sessions at The Tooting Bec Lido Pavilion to explain the investigation and proposals at the stated times below:

- Weekday 17 September 4pm-7pm
- Weekend 28 September 1pm-4pm

We will be advertising the Notice of Proposal for the Traffic Management Order in the Wandsworth Times on Thursday 12 September 2024, allowing a period of 21-days statutory consultation from that date.

Depending on the representations received, it is anticipated that the new single yellow lines could be introduced during the Autumn 2024.
