

Review of Polling Districts and Polling Places 2024

Introduction & background

Wandsworth Borough Council has undertaken a review of its polling districts and polling places.

Under the provisions within the Electoral Registration and Administration Act 2013, the previous statutory review of all the polling districts and polling places in Wandsworth was undertaken in 2019. The next statutory review must be completed by January 2025.

The aim of the review is to ensure that:

- All electors have as reasonable facilities for voting as are practicable in the circumstances; and that
- So far as is reasonable and practicable that the polling places are accessible to all electors having regard to the accessibility needs of disabled persons
- To attempt to take into account natural boundaries for example railway lines, major roads and rivers.

Roles and responsibilities and definition of terms

The Council

The statutory responsibility for reviewing UK Parliamentary polling districts and places rests with each relevant local authority in Great Britain for any constituency as is situated in its area.

Depending on the structure of the local authority, it may not be the full council which makes the decisions on any changes to polling districts or polling places. Some local authorities have delegated that function to a committee or sub-committee. This will be set out in the council's constitution. For Wandsworth delegated authority sits with the General Purposes Committee.

The Electoral Registration Officer (ERO)

Where a local authority makes any alterations to the polling districts within its area, the ERO must amend the Register of Electors accordingly – either on a notice of alteration or by publishing a revised register. Wandsworth intend to publish the revised Register of Electors based on the new polling scheme on 1 February 2025.

The (Acting) Returning Officer

The election rules require the (Acting) Returning Officer to decide how many polling stations are required for each polling place and they must allocate electors to the polling stations in such manner as they think most convenient.

The Polling Scheme 2025-2029

The following is a ward by ward description of the location of each polling place and a map showing the current boundaries of the polling districts.


The only changes proposed to the existing scheme are as follow:

- Balham ward a change to tidy up the polling district labelling
- East Putney ward a change to tidy up the polling district labelling
- Lavender ward it is proposed that polling place Burridge Gardens Community Centre is confirmed as the venue for LVA polling district
- Nine Elms ward the polling places used in 2024 are confirmed going forward.

All districts and places will be kept under regular review.

Balham ward




It is proposed that that polling districts BHA(T) and BHA(B) are re-labelled, so that the only polling district in the ward which is in Tooting Parliamentary constituency is now labelled separately as BHF. Therefore BHA(B) will now be BHA and BHA(T) will be BHF. They will both continue to be served by the same polling place. These arrangements have worked well for both major polls in 2024.

It is recommended that all polling place venues to remain as they are currently designated.



East Putney ward




The currently designated Polling Districts and Places are now well established.

The separation into EPB(B) and EPB(P) was required in case there was a Parliamentary by-election before the UK Parliamentary General Election was held. This would have required the by-election to be held on the previous constituency boundaries.




Lavender ward


Trinity ward






